1.0 Online percentage rate tenders in 'B-1' Form are invited by the PUNE METRO POLITAN REGION DEVELOPMENT AUTHORITY for the following work from Contractors qualified in technical bid or Contractors registered in appropriate class of PWD/CPWD. Having experienced in at least one similar type of work The name of work, estimated cost, earnest money, security deposit, time limit for completion etc. are as under.

1.1 Tender form, conditions of contract, specifications and contract drawings can be downloaded from the e-Tendering portal of PUNE METRO POLITAN REGION DEVELOPMENT AUTHORITY/ Government of Maharashtra i.e. <https://mahaetenders.govt.in> after entering the details, payment of Rs. 1180/- (one thousand one hundred and eighty only) should be paid online using payment gateway. The fees of tender document will be non refundable. Further information regarding the work can be obtained from the above office.

1.2 Affidavit on Rs. 500/- stamp paper in prescribed form given in Annexure I sworn before Executive Magistrate / Notary, Additional Performance Security Deposit (if required), should be submitted in sealed covers addressed to the PUNE METRO POLITAN REGION DEVELOPMENT AUTHORITY with the name of the work written at the top of the envelope will be received in the office of the PUNE METRO POLITAN REGION DEVELOPMENT AUTHORITY during Bid Opening. Bids will be opened as per the Tender Schedule, in the presence of such intending Tenderers or his/ their authorized representatives who may be present at that time.

1.3 The offer the contractor shall remain valid for acceptance for a minimum period of 90days from the date fixed for opening of envelope 2. (main tender) & there after until it is withdrawn by contractor by notice in writing duly addressed to the authority opening the tender & sent by registered post acknowledgement due.

1.4 The tender notice shall form a part of the contract agreement.

1.5 The tenders are invited on the Departmental design only.

1.6 the tender if firm or company shall in their forwarding letter mention the names of all the partners of the firm or company (as the case may be) and the name of the partner who holds the power of attorney if any, authorizing him to conduct transaction on behalf of the firm or company

1.7 right is reserved to revise or amend the contract documents fully or part there of prior to the date notified for the receipt of tender. Such deviations/amendments if any, shall be communicated in the form of corrigendum or by a letter as may be considered suitable.

1.8 the tender shall enter his percentage rates in words & figures “below/above” in case there is difference between percentage written in figure and words, the lower offer will be taken as final.

1.9 No pages should be removed from, added in or replaced in the Tender.

1.10 Right is reserved to reject any or all tenders without assigning any reason thereof.

1.11. Tenders which do not fulfill all or any conditions or are incomplete in any respect are liable to summary rejection.

1.12. The Tenderer may, in the forwarding letter, mention any points he may wish to make clear but right is reserved to reject the same of the whole of the tenders if the same become conditional tender thereby.

1.13. All hot mix work items under this contract shall be carried out with fully automatic batch mix hot mix of suitable capacity.

1.14 The Rates Quoted by the Contractor shall be deemed to be inclusive of all taxes other than Goods and Service Tax 2017 that the contractor will have to pay for performance of this contract. The rates quoted by the contractor shall be exclusive of Goods and Service Tax 2017 which shall be paid extra by the employer at prevailing rates. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.

1.15 Joint Venture/consortiums is not allowed

1.16 Contractors registered in appropriate class of PWD/CPWD will not be required to be qualified in technical bid. i.e. They will be treated as qualified in technical bid based on their valid registration certificate in appropriate class in PWD / CPWD and eligible to compete for tendered amount.
