NOTICE INVITING PROPOSALS

Pune Metropolitan Region Development Authority hereby invites proposals from eligible agencies for "Appointment of a Project Management Consultant for the Indrayani River Pollution Abatement Project under the jurisdiction of the PMRDA region"

Introduction:

Pune Metropolitan Region Development Authority represented by the Metropolitan Commissioner and CEO (the "Authority"/ "PMRDA") was constituted by the Government of Maharashtra and is the planning, development, coordinating and implementing agency to ensure balanced regional development with sustainable growth of the Pune Metropolitan Region, which covers an area of about 6914.26 square kilometers.

The Authority invites proposals (the "Proposals") for selection of an PMC (the "PMC") who shall provide the specified services and perform the role and functions set out in the RFP such as -

- To review the sanctioned DPR, study detailed survey, detailed project reports DPR of project covering Civil, Mechanical, Electrical & Automation, SCADA Works assisting PMRDA for getting approvals.
- 2. Providing services for preparation of Tender Documents and Bid Process Management including preparing proposal for getting requisite permissions from various concerned competent authorities.
- 3. Functioning as Project Management Consultant & Technical Auditor
- 4. After completion of the project Supervision and Monitoring of Operation and Maintenance (O&M) and assist management for a period of maximum 15 year.

General Conditions

- 1. The applicant Indian Firm should have been incorporated under the Companies Act 2013/ LLP Act 2008/ partnership registered under the India Partnership Act 1932 and in case of Foreign Firm it should be established under respective appropriate acts of their respective country and should have at least one operational office in India that has been in existence for a minimum of one year prior to the submission of this proposal in India.
- 2. The consulting firm shall have the required experience as required under eligibility conditions Part –II Data sheet.
- 3. Joint Venture/Consortium is not permitted to bid.
- 4. The Consultants should have reputed made software of Water Gems, Bentley, ESRI, Autodesk software as may be required for designing of different components of Sewerage & water supply works including Pumping Main/Gravity Main, /collection network, Hydraulic design for Sewage Treatment Plant, wet well, Under Ground Tanks, such as Sewer-CAD/ Sewer-Gem, AutoCAD, BIM Revit, GIS Software with updated version etc.

- 5. To be eligible for evaluation of the Proposal, the Applicant shall fulfill the minimum qualification criterion and shall obtain **60 marks** in technical score under QCBS criteria.
- 6. The Consultancy Team shall consist of the key personnel (the "Key Personnel") who shall discharge their respective responsibilities as defined in Tech Form-4 & 4A of this RPF.
- 7. The Consultants should have minimum 30 Nos technical personnel's staff on payroll.

Other conditions:

 Consultancy Services /design/ Construction, pre tendering, post tendering etc. shall be done as per MJP/PWD/GoM /GOI/MIDC Standards as specified by the Engineer-incharge.
