- 1.1 Tender form, conditions of contract, specifications and contract drawings can be downloaded from the e-Tendering portal of PUNE METROPOLITAN REGION DEVELOPMENT AUTHORITY, PUNE/ Government of Maharashtra i.e. <https://mahaetenders.gov.in> after entering the details, payment of **Rs.1180/-** should be paid online using payment gateway. The fees of tender document will be non refundable. Further information regarding the work can be obtained from the above office.
- 1.2 ~~Affidavit on Rs.500/- stamp paper in prescribed form given in Annexure I sworn before Executive Magistrate/ Notary, Additional Performance Security Deposit (If required), should be submitted in sealed covers addressed to the PUNE METROPOLITAN REGION DEVELOPMENT AUTHORITY, PUNE with the name of the work written at the top of the envelope will be received in the office of the PUNE METROPOLITAN REGION DEVELOPMENT AUTHORITY, PUNE during Bid Opening. Bids will be opened as per the Tender Schedule, in the presence of such intending Tenderers or his/ their authorized representatives who may be present at that time.~~
- 1.3 The offer the contractor shall remain valid for acceptance for a minimum period of 120 days from the date fixed for opening of envelope 2. (main tender) & there after until it is withdrawn by contractor by notice in writing duly addressed to the authority opening the tender & sent by registered post acknowledgement due.
- 1.4 The tender notice shall form a part of the contract agreement.
- 1.5 The tenders are invited on the Departmental design only.
- 1.6 The tender if firm or company shall in their forwarding letter mention the names of all the partners of the firm or company (as the case may be) and the name of the partner who holds the power of attorney if any, authorizing him to conduct transaction on behalf of the firm or company
- 1.7 Right is reserved to revise or amend the contract documents fully or part there of prior to the date notified for the receipt of tender. Such deviations/amendments if any, shall be communicated in the form of corrigendum or by a letter as may be considered suitable.
- 1.8 The tender shall enter his percentage rates in words & figures “below/above” in case there is difference between percentage written in figure and words, the lower offer will be taken as final.
- 1.9 No pages should be removed from, added in or replaced in the Tender.
- 1.10 Right is reserved to reject any or all tenders without assigning any reason thereof.
- 1.11 Tenders which do not fulfill all or any conditions or are incomplete in any respect are

liable to summary rejection.

- 1.12 The Tender may, in the forwarding letter, mention any points he may wish to make clear but right is reserved to reject the same of the whole of the tenders if the same become conditional tender thereby.
- 1.13 All hot mix items under this contract shall be carried out with 40 to 60 MTPH capacity Batch mix hot mix plant.
- 1.14 For GSB / WMM / MPM and BUSG work mechanical vibratory screening unit which is must/ mandatory for screening of metal under required for GSB / WMM / MPM and BUSG work.
 - (a) Documentary evidence (chalan) that he has procured asphalt from Government Refinery shall be produced to the Engineer in charge or his representative.
 - (b) Contractor shall provide online facility to Engineer in charge or his representative for online Verification of the Documentary evidence (Chalan) Submitted to him. Engineer in charge or his representative shall verify the transaction online and take print out of the online document.
 - (c) Attested copy of the print out of the online document shall be kept on record along with the Documentary evidence (chalan).
- 1.15 Extraction Test of Bitumen Mix.

The binder content of hot mix material shall be determined by ignition method only as specified in AASHTO T308. The testing by ignition method shall be done in furnace which shall be equipped with internal balance.
- 1.16 The Rates Quoted by the Contractor shall be deemed to be inclusive of all taxes other than Goods and Service Tax 2017 that the contractor will have to pay for performance of this contract. The rates quoted by the contractor shall be exclusive of Goods and Service Tax 2017 which shall be paid extra by the employer at prevailing rates. The employer will perform such duties in regard to the deduction of such taxes at sources as per applicable law.
- 1.17 Joint Venture/consortiums is not allowed
- 1.18 Contractor Those who has experience and fulfilling of qualifying criteria.
- 1.19 Time Duration of work: 3 Months.
- 1.20 Liquidated damage contractor shall pay liquidated damage to authority for each day that the work completion date exceed more than stipulated in tender at the rate of **Rs 14,050/-** per day.
- 1.21 The Bill for work completion will not be processed in absence of 'Satisfactory' report from SQM/ SSQM.
- 1.22 Third Party Inspection by SQM/ SSQM is mandatory requirement and payment of their fees will be responsibility of PMRDA. PMRDA will plan the SQM/ SSQM visit at

various important stages of work so as to avoid any non-compliance at the completion stage of work.

- 1.23 A Third Party Quality Audit team will be appointed by PMRDA and based on satisfactory Compliance RA Bill and Final Bill will be processed. The contractor will extend all the cooperation in the form of testing equipment, manpower and consumables to the third party quality audit team.
- 1.24 The Bill is to be submitted to PMRDA through IWMS and if required in usual method i.e. through MB writing also. The selected Bidder will be given IWMS login ID for the work.
- 1.25 Charges for Labour insurance as well as Work insurance shall borne by the Contractor as per PMRDA's Office Circular No.PMRDA/मआक/६७/२०२४ Dated 17/15/2024
