This role is critical for the proposals of the PMRDA Structure Plan, ensuring it aligns with State-level Development goals and sustainable urban growth strategies.

1. Scope of Work for Senior Consultant in Transportation Planning

The **Senior Consultant in Transportation Planning** is required to assist the Town Planning Officer for preparing the Structure plan which is a long-term vision for movement of people and goods with an integrated land use approach for a region and provides a strategy and investment program to meet the vision. It aims to provide both intercity and intra-city connectivity across the designated region. The scope of work would be as follows: -

- i. To suggest transport and communication network to be provided in the Structure Plan by identifying new development areas that will generate future transport demand.
- ii. To indicate the road infrastructure, other than the classified roads, to be provided
- iii. To suggest regional/town level mobility plan containing inter and intra city connectivity on studying and analysing the existing Comprehensive Mobility Plan.
- iv. To indicate appropriate road hierarchy to cater to the future transport demand, with feasibility of the alignment
- v. To analyse and review existing urban as well as regional transport projects and suggests measures for their effective utility.
- vi. To suggest public transport network and facilities for future
- vii. To prepare implementation plan including prioritisation of projects, funding as well monitoring mechanism
- viii. To facilitate stakeholders' consultations
- ix. To seek relevant updated data, in case of the data gaps, in order to perform the above activities
- x. To assist Town Planning Officer in the matters incidental to aspects of Transportation

2. Scope of Work for Senior Consultant in Environment Planning

The **Senior Consultant in Environment Planning** is required to ensure that land use strategies align with sustainability goals, legal regulations and climate objectives. The scope of work would be as follows: -

- i. To identify major environmental concerns of the area and suggest appropriate planning / strategic interventions for their mitigation
- ii. To review existing public utilities and services and suggest sites suitable for public utilities like solid waste management, sewage treatment and disposal
- iii. To suggest planning / strategic interventions to recharge/improve underground water level
- iv. To review and identify the areas which can be denoted as Hill Top Hill Slope (HTHS) on scientific basis.
- v. To suggest measures for preservation, conservation and development of areas of natural endowment and landscape.
- vi. To verify and correct mapping of all geographic features of ecological significance like lakes, rivers, nallahs (natural drains), forest areas, HTHS, eco-sensitive areas.
- vii. To suggest sites /areas suitable for regional / town level parks
- viii. To procure and analyse environmental data (secondary) to suggest measures for promoting harmony between human-made and natural systems.
- ix. To prepare implementation plan including prioritisation of mitigation measures, funding as well monitoring mechanism
- x. To prepare documentation explaining approach and methodology adopted for carrying out the above activities.
- xi. To facilitate stakeholders' consultations
- xii. To seek relevant updated data, in case of the data gaps, in order to perform the above activities
- xiii. To assist Town Planning Officer in the matters incidental to aspects of Environment

3. Scope of Work for GIS Expert:-

- i. Design the overall GIS strategy, data model, and standards aligned with structure plan and existing data.
- ii. Establish and oversee the central spatial database, metadata, and data governance framework for all layers.
- iii. Lead integration of transport, land use, and environmental datasets for network, accessibility, and suitability analyses.
- iv. Verify, manage, and maintain spatial and attribute databases related to land use, zoning, infrastructure, utilities, transport networks, and environmental layers.
- v. Specify, supervise, and interpret remote sensing and aerial imagery for base maps and change-detection studies.
- vi. Perform advanced spatial modelling and scenario comparison to support corridor selection and environmental impact assessments
- vii. Coordinate with PMRDA and other agencies to source authoritative datasets and ensure interoperability with existing systems
- viii. Review and assure quality of all GIS data and analyses produced by the project team, Consultants.
- ix. Integrate GIS with planning tools (CAD, remote sensing, other existing data)
- x. Generate GIS-based thematic maps for planning, policy formulation, and statutory submissions.
- xi. Support implementation of GIS-based planning portals, web GIS applications, and visualization tools.
- xii. To assist Town Planning Officer in the matters incidental to aspects of GIS.

4. Scope of Work for GIS Analyst:-

- i. Collect, clean, georeference, and standardize spatial and non-spatial data from various departments, and surveys.
- ii. Digitize transport, land use, and environmental features from imagery/CAD and maintain accurate GIS layers and attributes.
- iii. Execute routine spatial analyses (buffers, overlays, catchments, accessibility) to support transport and environment planning tasks.
- iv. Prepare, update, and validate GIS databases, checking for topology errors, missing fields, and data inconsistencies
- v. Produce clear thematic maps and graphics for reports, presentations, and stakeholder consultations as per approved templates
- vi. Process GPS/field data, support field verification, and incorporate corrections into the GIS database
- vii. Maintain basic documentation and metadata, and provide day-to-day GIS technical support to the Senior Consultant and team.
- viii. Ensure data accuracy, integrity, quality control, and version management.
- ix. To assist Town Planning Officer in the matters incidental to aspects of GIS.
